Elektromotive Group Limited To Acquire South Korea's Dream T Entertainment

Propels Elektromotive to expand services in artiste management and talent training

15 December 2016, Singapore – Elektromotive Group Limited (LEX: SP), the leading provider of technology and engineering solutions for electric vehicle charging stations has announced their plans to acquire a 63.13 percent stake in Dream T Entertainment Co., Ltd ("**Dream T**"), a company incorporated in South Korea for S\$22.7 million.

One of Korea's most sought after K-pop group – Girl's Day, was in Singapore as special guests for the announcement.

Dream T and its subsidiary, YMC Entertainment Co., Ltd ("YMC"), are leading artiste management companies which produce various genres of music, dramas, sound track as well as manage a variety of artistes, including Girl's Day, MAP6, and famous actors such as Hyun-Woo Ji and Soo-Ah Hong.

The proposed acquisition aims to expand the Group's services with new offerings which include representing Dream T and YMC artistes, concert and events organisation and training for young talents in South East Asia. The company will be based in Singapore to provide its services for South East Asia and intends to hire employees to engage in various entertainment businesses.

"At Elektromotive, we believe in focusing our efforts and resources into areas with high growth potential and the Korean entertainment industry is a perfect example. Singapore's lifestyle culture is heavily influenced by Korean brands and personalities; from, K-pop to K-dramas, even cosmetic and fashion brands. This proposed acquisition meets our corporate objectives of diversifying revenue and earnings stream through various platforms. We look forward to strengthening the brand's overall presence in Asia Pacific," said Mr Luke Ng Kai Man, Executive Director of Elektromotive Group Limited.

"Our objective is to provide the best management platform for our artistes and this acquisition is an effective way for us to achieve that goal. With this proposed acquisition, we hope to rapidly increase the reach of Korean talents throughout South East Asia's entertainment industry," said Jong-Suk Lee, CEO of Dream T.

Founded in 2009, Dream T is an artist management company that has its roots in South Korea. The company started expanding its circle of influence and acquired an 80% stake in YMC last year. Current artists include Girl's Day, MAP6, Soo-Ah Hong, and Hyun-Woo Ji.
