# 1. INTRODUCTION

CapitaLand Mall Trust Management Limited (the "Manager"), as manager of CapitaLand Mall Trust ("CMT"), refers to the announcement dated 22 January 2020 (the "Joint Announcement") issued by the Manager and CapitaLand Commercial Trust Management Limited, as manager of CapitaLand Commercial Trust ("CCT"), in relation to the proposed merger (the "Merger") of CMT and CCT through the acquisition by CMT of all the issued and paid-up CCT Units by way of a trust scheme of arrangement, to be effected in accordance with the Singapore Code on Take-overs and Mergers (the "Code").

Unless otherwise defined, all capitalised terms used and not defined herein shall have the same meanings given to them in the Joint Announcement.

# 2. DEALING

Pursuant to Rule 12.1 of the Code, the Manager wishes to announce the following dealing in CMT Units by Mr. Puah Tze Shyang, an associate of CMT<sup>1</sup>:

Based on the information received from Mr. Puah Tze Shyang on 24 March 2020, Mr. Puah Tze Shyang holds 50,000 CMT Units after the dealing reported above, representing approximately 0.001% of the total number of issued CMT Units<sup>2</sup>.

Mr. Puah Tze Shyang is an "associate" of CMT under the Code in relation to the Merger by virtue of the fact that he is a director of certain subsidiaries and associated companies of CL. As such, the Code requires the dealing by Mr. Puah Tze Shyang in CMT Units to be disclosed.
