AWARD OF RMB10.517 MILLION WASTE WATER TREATMENT PLANT CONTRACT IN CHINA

The Board of Directors ("**Directors**") of Tritech Group Limited (the "**Company**" and together with its subsidiaries, the "**Group**") wishes to announce that its indirect wholly-owned subsidiary, 安徽省科林环 境生物技术有限公司 (*Anhui Clean Environment Biotechnology Co Ltd)("**Anhui Clean Environment Biotechnology**"), had on 22 February 2017 received an award for a project with an aggregate project contract value of RMB10.517 million in relation to the design, installation and construction of a waste water treatment plant with a capacity of 2,500 m³/Day (the "**Waste Water Treatment Plant**") located in the region of Qinhuangdao of Hebei Province, the People's Republic of China (the "**Contract**") by 华 润 雪 花 啤 酒 (秦 皇 岛) 有 限 公 司 (*Resources Snow Brewer (Qinhuangdao) Co Ltd of China)("**Resources Snow Brewer**").

The main scope of the Contract includes, *inter alia*, the design, supply of electrical instruments and process equipment, installation, delivery and construction of the layout, Waste Water Treatment Plant (including civil construction and structural works which will be undertaken by an appointed subcontractor).

The commencement date for the works in relation to the Waste Water Treatment Plant is 09 March 2017 and the expected completion date is 14 December 2017 (a period of 280 days).

None of the Directors or substantial shareholders of the Company has any interest, direct or indirect, in the Contract (other than through their shareholdings in the Company).

The Contract is not expected to have any material impact on the consolidated earnings per share and/or net tangible assets per share of the Group for the current financial year ending 31 March 2017.
