## ALLOTMENT AND ISSUANCE OF SHARES PURSUANT TO WARRANT EXERCISE

The Board of Directors (the “**Board**”) of ValueMax Group Limited (the “**Company**”) wishes to announce the number of issued ordinary shares of the Company has increased from 868,092,559 ordinary shares (exclusive of 100,000 treasury shares) to 868,181,159 ordinary shares by way of allotment and issuance 88,600 warrants at the exercise price of S\$0.36 each, on 14 October 2024.
