Frasers Property Limited ("FPL") holds a 100% direct interest in each of FCAM and Frasers Property Retail Trust Holdings Pte. Ltd. ("FPRTH"). FCAM and FPRTH hold units in FCT ("Units"). FPL therefore has a deemed interest in the Units in which each of FCAM and FPRTH has an interest, by virtue of Section 4 of the Securities and Futures Act 2001 of Singapore.

Charoen Sirivadhanabhakdi and the estate of the late Khunying Wanna Sirivadhanabhakdi, each owns 50.0% of the issued and paid-up share capital of TCC Assets Limited ("TCCA");

- TCCA holds a majority interest in FPL;
- FPL holds a 100% direct interest in each of FCAM and FPRTH; and
- each of FCAM and FPRTH directly hold units in FCT.

Charoen Sirivadhanabhakdi therefore has a deemed interest in the units in FCT in which FPL has an interest, by virtue of Section 4 of the SFA.

The REIT Manager had, on 25 March 2025, launched an equity fund raising by way of a private placement ("Private Placement"). A total of 105,264,000 new Units ("New Units") were issued on 4 April 2025 under the Private Placement at an issue price of \$\$2.090 per New Unit.
