As CEO of multiple renowned hospitals, Mr Lee has implemented new integrated and specialist care services, transformed service standards, and brought new levels of sophistication to complex hospital groups.

Mr Lee graduated with an engineering degree from the Imperial College of Science, Technology and Medicine in London. He received his Master of Business Administration (MBA) degree in 2007. Besides the healthcare sector, Mr Lee was formerly with DBS Bank and had a strategic investments role at Singapore Power. At the national level, he was a Management Committee member for the Singapore Quality Award to promote Business Excellence; and he now serves as a Co-chair of the Technical Committee for Healthcare and Health Informatics, under the Biomedical and Health Standards Committee of Enterprise Singapore.
