The Issuer wishes to clarify that the definition of "%Spreadlevel_t" in the "Leverage Strategy Formula" section in each of the Supplemental Listing Documents and the Termsheets should be as follows and the Leverage Strategy Formula of each Further Issue has been calculated using the following definition of "%Spreadlevel_t" in practice from the respective date of each Further Issue:

%SpreadLevel,

means, in respect of each Observation Date(t), a rate which shall be determined with respect to such Valuation Date(t) by the Calculation Agent as the difference between (1) the ICE LIBOR USD 12 Month, as published on Reuters RIC USD1YFSR= and (2) <u>USD SWAP OIS 1Y</u>, as published on <u>Reuters RIC USD1YOIS=</u> or any successor page, each being the rate as of day (t-2), provided that if any of such rates is not available, then that rate shall be determined by reference to the last available rate that was published on the relevant Reuters page. Upon the occurrence or likely occurrence, as determined by the Calculation Agent, of modification or cessation in the provision of LIBOR, the Calculation Agent may make adjustments as it may determine appropriate to account for the relevant event or circumstance, including but not limited to using any alternative rates from such date, with or without retroactive effect as the Calculation Agent may in its sole and absolute discretion determine.

Provided that if such difference is negative, **SpreadLevel**, should be 0%.

The above amendments are being made pursuant to Condition 8(b) of the terms and conditions of the Further Issues (the "Conditions") and shall be deemed to take effect from the respective date of each Further Issue. This Announcement constitutes notice of such amendments to holders pursuant to Condition 9(b) of the Conditions. Except as stated above and in any other applicable announcements

made by the Issuer before the date of this Announcement, all the information in the Supplemental Listing Documents and Termsheets remains unchanged and is not affected by such amendments.
