Conversion and cancellation of S\$4,000,000 in aggregate principal amount of S\$175,000,000 2.5 per cent. Convertible Bonds due 12 September 2017, resulting in an issue of an aggregate of 2,804,065 new units in CCT. The total number of units in CCT in issue has increased from 3,087,657,198 to 3,090,461,263. As a result of such increase, the direct interest of E-Pavilion Pte. Ltd. and deemed interest of CapitalLand Investments Pte Ltd in units in CCT have decreased from 6.00% to 5.99%.
