Ltd. received valid acceptances for 33,364,370 Offer Shares and there owned, controlled or had agreed to acquire (including valid acceptances of the Offer) an aggregate of 140,612,530 Shares. The 33,364,370 Offer Shares represent valid acceptances of the Offer received by Do Global Healthcare International Pte. Ltd. during the period when the Offer was open for acceptances (being the period commencing from 15 June 2020 and ending on 13 July 2020).
