On 7 August 2026, Rawabi Holding Closed Joint Stock Company (formerly known as Rawabi Holding Company Limited) ("RHC JSC") entered into a share purchase agreement with Rawabi Energy Company ("REC"), a 99.98%-owned subsidiary of RHC JSC, pursuant to which RHC JSC agreed to transfer 723,106,389 ordinary shares in Vallianz Holdings Limited ("Shares"), representing approximately 59.68% of the total issued shares in Vallianz Holdings Limited, to REC (the "Transfer"), as part of an internal restructuring exercise.

The Transfer has completed on 24 August 2026 and the Shares are now directly held by REC.

3. United Rawabi Investment Company holds 41% of the shares of RHC JSC and is deemed interested in the Shares held by REC.
