On 29 September 2015, 281,458,890 shares in Oceanus Group Limited ("Shares") were issued in favour of BW Investment Limited ("BWIL").

Borrelli Walsh Asia Limited ("BWAL") is the sole shareholder of BWIL and accordingly holds more than 50% of the voting rights in BWIL. Bombay Bicycle Club Limited ("BBCL") holds 56.5% of the shares in BWAL (being more than 50% of the voting rights in BWAL). Jacqueline Walsh and Cosimo Borrelli respectively hold 25% of the shares in BBCL (being not less than 20% of the voting rights of BBCL) and 75% of the shares in BBCL (being more than 50% of the voting rights in BBCL).

The interests as a percentage figure of the total number of voting shares in this notification is derived based on the total number of issued Shares as of 29 September 2015, being 4,566,852,832 Shares.

The Shares were issued as settlement for outstanding interest owed to BWIL on a loan made by BWIL to Oceanus Group Limited and were issued at the notional consideration of S\$0.013 per Share for 79,737,360 Shares and S\$0.00864 per Share for 201,721,530 Shares.
