FURTHER UPDATE ON COURT HEARING DATE TO APPROVE CAPITAL REDUCTION

1. INTRODUCTION

- 1.1 The Company refers to the announcement made on 13 June 2023 in relation to the update on the Court Hearing date to approve the Capital Reduction (the "**13 June Announcement**").
- 1.2 Unless otherwise defined, capitalised terms used herein shall bear the same meanings as set out in the circular dated 18 May 2023 issued by the Company in relation to the Proposed Distribution and Delisting or the 13 June Announcement (as applicable).

2. FURTHER UPDATE ON COURT HEARING DATE TO APPROVE CAPITAL REDUCTION

- 2.1 As mentioned in the 13 June Announcement, the Company had filed an Application in the Court to apply for an order of the Court approving the Capital Reduction, and the Court had redirected that the Court Hearing for the Application be heard on 20 June 2023 at 10.00 a.m. (Singapore time).
- 2.2 The Company wishes to update Shareholders that due to unforeseen circumstances unrelated to the Company and to the Company's Application, the Court has further redirected that the Court Hearing be postponed to 22 June 2023 at 10.00 a.m. (Singapore time) instead.
- 2.3 The Company and the Offeror will make further announcements on the key events and indicative timetable in respect of the Proposed Distribution, Delisting and Exit Offer in due course.
