AZEUS SECURES HK\$14.4 MILLION (APPROXIMATELY US\$1.8 MILLION) IT SERVICES PROJECT FROM THE HONG KONG GOVERNMENT

- ***Total value of contract wins year-to-date exceed HK\$112.9 million (about US\$14.5 million)***
- ***Latest win awarded under the Standing Offer Agreement for Quality Professional Services 4 (“SOA-QPS4”)***

Singapore, 2 November 2017 – Azeus Systems Holdings Ltd (“**Azeus**” or the “**Group**”) today announced that it has secured a new IT services project worth approximately HK\$14.4 million (about US\$1.8 million) from the Hong Kong Government which includes a one-off implementation value of HK\$9.9 million (about US\$1.3 million) and a HK\$4.5 million (about US\$0.6 million) maintenance contract for 3 years.

The latest project involves the provision of a full suite of IT services, encompassing design, implementation and system maintenance works for a new customised analytical tool for a key government department.

The design and implementation works started in October 2017 and planned to be completed in 15 months followed by three months of system nursing period. Upon completion of the nursing services, Azeus will provide 36 months of system maintenance services to the new analytical tool.

Azeus’ latest project win brings the total value of contracts secured by the Group in the year to date to over HK\$112.9 million (about US\$14.5 million), and is awarded under the Standing Offer Agreement for Quality Professional Services 4 (“**SOA-QPS4**”), which was conferred to the Group for the fifth consecutive term in July 2017.

Mr. Lee Wan Lik, Managing Director of Azeus, said, “We are heartened by the momentum of our contract wins over the last 10 months. This serves to reaffirm not only the quality and reliability of Azeus’ IT solutions and service delivery, but also our ability in continuously meeting the needs of our customers.
