Australand Property Limited ("APL") as trustee of Australand Property Trust ("APT") had declared a trust in favour of FCLI pursuant to a declaration of trust dated 21 June 2016 (the "Declaration of Trust"). Pursuant to the Declaration of Trust, APL, as trustee of APT, holds the Trust Property upon trust absolutely for FCLI. The "Trust Property" includes 292,155,000 Units held by APL, as trustee of APT (the "Sponsor Units"). Accordingly, FCLI is deemed interested in the Sponsor Units under section 4 of the Securities and Futures Act, Chapter 289 of Singapore ("SFA").

Prior to the issuance of the Management Fee Units, FCLI held an aggregate of 7,953,479 Units ("Previously Nominated Units") which were issued as payment of management fees payable to (i) FLIAM, as manager of FLT (the "REIT Manager"), and (ii) FLT Australia Management Pty Ltd, as manager of FLT Australia Trust (the "HAUT", and the manager of the HAUT, the "HAUT Manager"), in respect of FLT and the HAUT respectively, and which FLIAM and the HAUT Manager had nominated FCLI to receive. FCLI holds the Previously Nominated Units through a nominee account with OCBC Securities Private Limited. Accordingly, FCLI's interest in the Previously Nominated Units is a deemed interest under section 4 of the SFA.

The 7,651,217 Management Fee Units which FCLI was nominated by the REIT Manager and the HAUT Manager to receive is held by FCLI through a nominee account with OCBC Securities Private Limited. As such, FCLI's interest in the Management Fee Units is a deemed interest under section 4 of the SFA.

Accordingly, following the receipt of the Management Fee Units by FCLI, FCLI is deemed interested in an aggregate of 307,759,696 Units (the "FCLI Units").

FLIAM has a direct interest in 373,983 Units (the "FLIAM Units").

Frasers Centrepoint Limited ("FCL") is the immediate holding company of FCLI and FLIAM. Accordingly, FCL is deemed to be interested in the aggregate of 308,133,679 Units, which comprise the FCLI Units and the FLIAM Units, under section 4 of the SFA.

Each of Charoen Sirivadhanabhakdi and his spouse, Khunying Wanna Sirivadhanabhakdi, owns more than 20% of the issued and paid-up share capital of TCC Assets Limited ("TCCA"). TCCA is in turn the majority shareholder of FCL. Accordingly, each of Charoen Sirivadhanabhakdi and Khunying Wanna Sirivadhanabhakdi is deemed to be interested in the 308,133,679 Units under section 4 of the SFA.

Charoen Sirivadhanabhakdi and Khunying Wanna Sirivadhanabhakdi also jointly hold more than 50% of the issued share capital of Siriwana Company Limited ("Siriwana"), which in turn holds more than 20% of the issued share capital of Thai Beverage Public Company Limited ("ThaiBev").

Further, Charoen Sirivadhanabhakdi and Khunying Wanna Sirivadhanabhakdi also jointly hold a 100% direct interest in MM Group Limited ("MM Group"). MM Group holds a 100% direct interest in each of Maxtop Management Corp. ("Maxtop"), Risen Mark Enterprise Ltd. ("RM") and Golden Capital (Singapore) Limited ("GC"). Maxtop, RM and GC collectively hold more than 20% of the issued share capital of ThaiBev.

ThaiBev holds a 100% direct interest in International Beverage Holdings Limited, which in turn holds a 100% direct interest in InterBev Investment Limited ("IBIL"). IBIL holds more than 20% of the issued share capital of FCL. Accordingly, each of Charoen Sirivadhanabhakdi and Khunying Wanna Sirivadhanabhakdi is deemed to be interested in the 308,133,679 Units under section 4 of the SFA.
