On 3 September 2020, Frasers Centrepoint Asset Management Ltd. (the "FCT Manager"), the manager of FCT, announced, among others, the proposed acquisition of approximately 63.11% of the total issued share capital of AsiaRetail Fund Limited and the proposed divestment of Bedok Point (the "Transactions").

In conjunction with this announcement, FCT will also be convening an Extraordinary General Meeting on 28 September 2020 to seek FCT Unitholders' approval for, among others, the resolutions relating to the proposed Transactions.

 not allowed.
- FCT Unitholders are not permitted to appoint a proxy to join the live webcast on their behalf.
- FCT Unitholders who hold FCT Units through nominee accounts are required to submit an <u>e-copy of</u> their proof of FCT Unitholdings when they RSVP (for example, a letter from the nominee bank), failing which, they will not be permitted to join the live webcast.
