The Company will endeavour to issue its sustainability report for FY2019 by 30 July 2020. The Company will also complete the audit, issue the annual report and hold the FY2019 AGM as soon as it is in a position to do so.

Shareholders and potential investors of the Company are advised to read this announcement and any further announcements made by the Company carefully. Shareholders and potential investors of the Company are advised to refrain from taking any action with respect to their securities in the Company which may be prejudicial to their interests, and to exercise caution when dealing in the securities of the Company.
