As a result of the transfers by SI and Island of their 34,633,008 ordinary shares in BSEL and 2,829,600 ordinary shares in BSEL respectively to LRG Property Investment Pte. Ltd. ("LRG"), LP ceased to have any deemed interest in the LP Deemed Interest Shares.

In addition, LP also transferred 864,000 ordinary shares in BSEL to LRG. Accordingly, LP ceased to have any direct interest in the ordinary shares in BSEL.
