The net loss for 1H2022 is mainly attributable to:

- a decline in revenue, which was primarily due to the reduction in number of veterinarians in 1H2022, as compared with the previous corresponding financial period and the closure of the Group's Traditional Chinese Medicine veterinary clinic in March 2021; and
- (ii) an increase in professional fees, which was mainly due to the professional fees incurred for the proposed acquisition of the entire issued and paid-up share capital in AlDigi Holdings Pte. Ltd. from RHT AlDigi Financial Holdings Pte. Ltd. (the "Proposed Acquisition"), details of the Proposed Acquisition as set out in the Company's announcements dated 30 December 2021 and 28 April 2022.

The Group is in the process of finalising its unaudited consolidated financial results for 1H2022. Further details of the Group's financial performance will be disclosed when the Company announces the unaudited consolidated financial results of the Group for 1H2022, which will be released on or before 14 August 2022.

In the meantime, the Board wishes to advise shareholders and potential investors of the Company to exercise caution when dealing in the shares of the Company. If in doubt as to the action they should take, shareholders and potential investors of the Company should consult their stockbrokers, bank managers, solicitors, accountants, tax advisers or other professional advisers.
