



## Invitation to the SIAS-ThaiBev Dialogue Session for ThaiBev Shareholders

On 17 July 2024, Thai Beverage Public Company Limited (“**ThaiBev**”), through its indirect wholly-owned subsidiary InterBev Investment Limited (“**IBIL**”), proposed a share swap with TCC Assets Limited (“**TCCAL**”) (“**Proposed Share Swap**”). Under the Proposed Share Swap, IBIL will transfer to TCCAL all of its 28.78% shareholding in Frasers Property Limited, with TCCAL transferring to IBIL its 41.30% shareholding in Fraser and Neave, Limited.
