ARA in turn holds more than 50 per cent. of the voting rights of each of ARA Trust Management (Suntec) Limited ("ARA Suntec") and ARA Investors II Limited ("ARA Investors II"). By virtue of the foregoing, STC has a deemed interest in the Units in which each of ARA Suntec and ARA Investors II has a direct interest in.
