The Managers have announced the issuance of an aggregate of 15,441,157 new Stapled Securities in FHT on 4 November 2019 for the payment of the REIT Manager's, Trustee-Manager's and MIT Manager's management fees, and the serviced residence management fees by way of issue of new Stapled Securities. The total number of issued Stapled Securities increased from 1,894,216,910 to 1,909,658,067. The issuance of the new Stapled Securities resulted in a change in the percentage level of Maxtop's deemed interest in FHT.

 (i) Frasers Property Hospitality Trust Holdings Pte. Ltd. ("FPHTH") has a direct interest in an aggregate of 450,202,615 Stapled Securities (the "FPHTH Stapled Securities");
 (ii) Frasers Hospitality Asset Management Pte. Ltd. has a direct interest in an aggregate of 20,054,379 Stapled Securities (the "REIT Manager's Stapled Securities"); and
 (iii) Frasers Hospitality Pte. Ltd. ("FHPL") has a direct interest in an aggregate of 11,668,847 Stapled Securities (the "FHPL Stapled Securities", and collectively with the FPHTH Stapled Securities and the REIT Manager's Stapled Securities, the "FPL Stapled Securities"). Frasers Property Limited ("FPL") is the immediate holding company of FPHTH, the REIT Manager and FHPL.

MM Group Limited holds a 100% direct interest in each of Maxtop, Risen Mark Enterprise Ltd. ("RM") and Golden Capital (Singapore) Limited ("GC"). Maxtop, RM and GC collectively holds more than 20 per cent. of the issued share capital of Thai Beverage Public Company Limited ("ThaiBev"). ThaiBev holds a 100% direct interest in International Beverage Holdings Limited, which in turn holds a 100% direct interest in InterBev Investment Limited. InterBev Investment Limited holds more than 20 per cent of the issued share capital of FPL.

Accordingly, Maxtop has a deemed interest in the FPL Stapled Securities, comprising a total of 481,925,841 Stapled Securities.

FHT is a stapled group comprising Frasers Hospitality Real Estate Investment Trust ("FH-REIT") and Frasers Hospitality Business Trust ("FH-BT"). The REIT Manager of FH-REIT is FHAM (the "REIT Manager") and the Trustee-Manager of FH-BT is Frasers Hospitality Trust Management Pte. Ltd. ("FHTM") (collectively with FHAM, the "Managers").

FPHTH was nominated by the following entities to receive the aggregate of 15,441,157 Stapled Securities issued to them as payment of management fees:

(a) FHAM nominated FPHTH to receive 7,047,501 Stapled Securities issued as payment of REIT management fees in respect of FH-REIT;

(b) FHTM nominated FPHTH to receive 39,918 Stapled Securities issued as payment of Trustee-Manager management fees in respect of FH-BT;

(c) FHT Australia Management Pty Ltd nominated FPHTH to receive 4,358,730 Stapled Securities issued as payment of MIT management fees in respect of FHT Australia Trust;

(d) FHPL nominated FPHTH to receive 2,175,526 Stapled Securities issued as payment of serviced residence management fees in respect of the non-UK properties of FH-REIT; and

(e) Frasers Hospitality UK Ltd. nominated FPHTH to receive 1,819,482 Stapled Securities issued as payment of serviced residence management fees in respect of the UK properties of FH-REIT.
