NOTICE IS HEREBY GIVEN that the Share Transfer Books and Register of Members of Sim Leisure Group Ltd. (the “**Company**”) will be closed at 5.00 p.m. (Singapore time) on 13 May 2026 (the “**Record Date**”) for the purpose of determining the entitlements of the Company’s shareholders (“**Shareholders**”) to a first and final tax-exempt (one-tier) dividend of Malaysian Ringgit (“**MYR**”) 0.04 per ordinary share in the capital of the Company (“**Share**”) in respect of the financial year ended 31 December 2025 (the “**Dividend**”). The Dividend was approved by Shareholders at the Annual General Meeting of the Company held on 29 April 2026.

Shareholders whose securities accounts with The Central Depository (Pte) Limited (“**CDP**”) are credited with Shares or whose names appear in the Register of Members of the Company, as at 5.00 p.m. (Singapore time) on the Record Date shall be entitled to the Dividend on the basis of the number of Shares standing to the credit of their securities accounts with CDP or the number of Shares held by them as stated in the Register of Members of the Company, as the case may be.

Shareholders who are entitled to receive the Dividend will receive the Dividend in Singapore Dollars (“**SGD**”). The conversion from MYR to SGD is based on the closing exchange rate of MYR100:SGD32.32 (the “**Conversion**”) on 29 April 2026, as extracted from the Monetary Authority of Singapore. After the Conversion, Shareholders who are entitled to receive the Dividend will receive the Dividend amounting to SGD0.012928 per Share.

Duly completed and stamped registrable transfers in respect of the Shares received by the Company’s Share Registrar at B.A.C.S. Private Limited, at 77 Robinson Road, #06-03, Robinson 77, Singapore 068896, up to 5.00 p.m. (Singapore time) on the Record Date will be registered to determine Shareholders’ entitlements to the Dividend.

The Dividend shall be paid on 22 May 2026.
