NOTICE OF ANNUAL GENERAL MEETING

NOTICE IS HEREBY GIVEN THAT the Annual General Meeting of Chaswood Resources Holdings Ltd will be held at 22 Cross Street, #03-54/61 China Square Central Singapore 048421 on Monday, 28 April 2014 at 10.00 am for the purpose of transacting the following businesses:-

AS ORDINARY BUSINESS

1. To receive and adopt the Audited Financial Statements for the financial year ended 31 December 2013 together with the Directors' Report and Independent Auditors' Report thereon. **Resolution 1**
2. To approve the payment of Directors' fees of S\$185,000/- (2013: S\$185,000/-) for the financial year ending 31 December 2014, payable quarterly in arrears. **Resolution 2**
3. To re-elect Datuk Jared Lim Chih Li who is retiring under Article 89 of the Articles of Association of the Company and has offered himself for re-election.
[See Explanatory Note 1] **Resolution 3**
4. To re-elect Mr Ng Teck Wah who is retiring under Article 89 of the Articles of Association of the Company and has offered himself for re-election.
[See Explanatory Note 1] **Resolution 4**
5. To note the voluntary retirement of Dato' Mohammed Azlan bin Hashim, who is retiring under Article 90 of the Articles of Association of the Company.

6. To re-appoint Messrs RSM Chio Lim LLP, Certified Public Accountants, as Independent Auditors of the Company for the financial year ending 31 December 2014 and to authorise the Directors to fix their remuneration. **Resolution 5**
7. To transact any other ordinary business which may be properly transacted at an Annual General Meeting.

AS SPECIAL BUSINESS

To consider and, if thought fit, to pass the following resolution (with or without amendments) as Ordinary Resolution.

8. Authority to issue shares
That pursuant to Section 161 of the Companies Act, Cap. 50 and Rule 806 of the Singapore Exchange Securities Trading Limited Listing ("SGX-ST") Manual Section B: Rules of Catalist (the "Catalist Rules"), the Directors of the Company be authorised and empowered to:
(A) (i) issue shares in the Company ("Shares") whether by way of bonus issue, rights issue or otherwise; and/or
(ii) make or grant offers, agreements or options (collectively "Instruments") that might or would require Shares to be issued, including but not limited to the creation and issue of (as well as adjustments to) options, warrants, debentures or other instruments convertible into Shares,
at any time and upon such terms and conditions and for such purposes and to such persons as the Directors of the Company may in their absolute discretion deem fit; and
(B) (notwithstanding the authority conferred by this Resolution may have ceased to be in force) issue shares in pursuance of any instruments made or granted by the Directors of the Company while this Resolution was in force,
provided that:
(a) the aggregate number of shares (including shares to be issued in pursuance of the Instruments, made or granted pursuant to this Resolution) to be issued pursuant to this Resolution shall not exceed one hundred per centum (100%) of the total number of issued shares in the capital of the Company (as calculated in accordance with sub-paragraph (b) below), of which the aggregate number of shares to be issued other than on a pro rata basis to shareholders of the Company shall not exceed fifty per centum (50%) of the total number of issued shares in the capital of the Company (as calculated in accordance with sub-paragraph (b) below);
(b) (subject to such calculation as may be prescribed by the SGX-ST) for the purpose of determining the aggregate number of shares that may be issued under sub-paragraph (a) above, the total number of issued shares shall be based on the total number of issued shares in the capital of the Company at the time of the passing of this Resolution, after adjusting for:
(i) new shares arising from the conversion or exercise of any convertible securities;
(ii) new shares arising from exercising share options or vesting of share awards which are outstanding or subsisting at the time of the passing of this Resolution; and
(iii) any subsequent consolidation or subdivision of shares;
(c) in exercising the authority conferred by this Resolution, the Company shall comply with the provisions of the Catalist Rules for the time being in force (unless such compliance has been waived by the SGX-ST) and the Articles of Association of the Company; and
(d) unless revoked or varied by the Company in a general meeting, such authority shall continue in force until the conclusion of the next Annual General Meeting of the Company or the date by which the next Annual General Meeting of the Company is required by law to be held, whichever is earlier.

Explanatory Notes:

Ordinary Business

1. (a) The detailed information of Datuk Jared Lim Chih Li and Mr Ng Teck Wah and their relationship with the Company's 10% shareholders can be found under the section entitled 'Board of Directors' in page 12 and 13 of the Annual Report.
(b) The relationship between Datuk Jared Lim Chih Li and Mr Ng Teck Wah with the Company can be found under the section entitled 'Interested Person Transaction' page 32 of the Annual Report.
(c) Save for the above, there is no relationship (including immediate family relationships) between the abovementioned Directors and the other Directors of the Company.
2. Dato' Mohammed Azlan bin Hashim will upon retirement as a Director at the Annual General Meeting, cease as the Chairman of the Board and member of the Audit, Nominating and Remuneration Committees of the Company.

Special Business

3. The Ordinary Resolution 6, if passed, will empower the Directors of the Company, effective until the conclusion of the next Annual General Meeting of the Company, or the date by which the next Annual General Meeting of the Company is required by law to be held or such authority is varied or revoked by the Company in a general meeting, whichever is the earlier, to issue shares, make or grant instruments convertible into shares and to issue shares pursuant to such instruments, up to a number not exceeding in total, 100% of the total number of issued shares in the capital of the Company, of which up to 50% may be issued other than on a pro-rata basis to the shareholders.

Notes:

- i. A member of the Company entitled to attend and vote at the Annual General Meeting is entitled to appoint one or two proxies to attend and vote in his/her stead. A proxy need not be a member of the Company.
- ii. Where a member appoints more than one proxy, the appointments shall be invalid unless he/she specifies the proportion of his/her shareholding to be represented by each proxy.
- iii. A corporation which is a member of the Company may authorize by resolution of its directors or other governing body, such person as it thinks fit to act as its representative at the meeting.
- iv. The instrument appointing a proxy must be deposited at the registered office of the Company at 80 Robinson Road #02-00 Singapore 068898 not less than forty-eight (48) hours before the time for holding the Annual General Meeting.
