ISSUE AND LISTING OF NEW UNITS UNDER THE DISTRIBUTION REINVESTMENT PLAN

CapitaLand Retail China Trust Management Limited (the “**Manager**”), the manager of CapitaLand Retail China Trust (“**CRCT**”), wishes to announce that 10,602,618 new units in CRCT (“**Units**”) will be issued at an issue price of S\$1.508 per new Unit to eligible unitholders of CRCT (“**Unitholders**”) who have elected to participate in the Distribution Reinvestment Plan (“**DRP**”) in respect of the distribution of 5.39 cents per Unit for the period from 1 January 2018 to 30 June 2018 (the “**Distribution**”).

The new Units will be credited to the securities accounts of Unitholders who have elected to participate in the DRP by 20 September 2018. The new Units will commence trading on the Main Board of Singapore Exchange Securities Trading Limited (the “**SGX-ST**”) at 9.00 a.m. on 20 September 2018.

The new Units will rank *pari passu* in all respects with the existing Units.

Following the issue of the new Units, the number of issued Units has increased from 969,946,518 to 980,549,136.

Distribution payments to eligible Unitholders who did not elect to participate in the DRP will be paid in cash on 20 September 2018.
