### **NTEGRATOR SECURES S\$8.56 MILLION CONTRACT EXTENSION FROM A LEADING NETWORK SERVICE PROVIDER IN THE REGION**

- *Contract extended by a repeated customer for telecommunication (“telecom”) pipe laying and maintenance works in the eastern, northern and western regions in Singapore*
- *Group continued its healthy contract winning momentum in the region and adds onto its outstanding order book of S\$65.9 million as of 30 June 2021*

**Singapore, December 1, 2021** – Ntegrator International Ltd (“**Ntegrator**” or the “**Group**”), a leading regional communications network specialist and systems integrator, today announced that it had secured a contract extension worth S\$8.56 million from a regional telecom provider for pipe installation and maintenance works in the eastern, northern and western regions in Singapore. The contract extension will commence in April 2022 and is expected to be completed by September 2022. The Group had already been working on a similar project in the eastern region of Singapore with the same customer.

The scope of the contract extension includes but is not limited to the following: provision of labour for pipe laying works and project management services with all related agencies and other contractors for mill and patch etc.

Commenting on the contract win, Mr. Christian Kwok-Leun Yau Heilesen, Executive Director of Ntegrator, said: ***“We envisage the demand for data and technology will grow rapidly in the region given the pandemic causing people to work from home more. Combined with the shift towards major telecom players divesting their infrastructure assets, we are therefore optimistic that there would a surge in demand for upgrading and maintenance of these assets as asset owners seek to window-dress these assets and maximize their valuation. Given the Group’s expertise in the telecom infrastructure market, Ntegrator***

*is poised to seize these opportunities to build up our order book and enhance our shareholder returns going forward.”*

Mr Jimmy Chang, Managing Director of Ntegrator, added: *“We are very grateful to secure a contract extension from a returning customer, endorsing us with a testament of our capability to deliver timely and quality installation and maintenance works across the region. We will continue to hunt for more of such opportunities in the region while enhancing our reputation providing infrastructure solutions for major telecom players in the region.”*

The contract extension is not expected to have any material impact on earnings of the Group for the financial year ending 31 December 2021.
