**RECTIFICATION ANNOUNCEMENT IN RESPECT OF THE COMPANY'S ANNOUNCEMENT DATED  
29 JULY 2019**

---

The Board of Directors (the "**Board**") of Libra Group Limited (the "**Company**" and together with its subsidiaries, the "**Group**") refers to the Company's announcement dated 29 July 2019 ("**Announcement**") in relation to the default judgments obtained by Allinton Engineering & Trading Pte. Ltd. ("**Allinton**") against Cyber Builders Pte. Ltd. ("**CB**") and Libra Building Construction Pte. Ltd. ("**LBC**") on 8 July 2019. The Board wishes to clarify that:

- (a) The Management of CB and LBC were notified of the default judgments on 23 July 2019 and, on 25 July 2019, CB and LBC received letters dated 24 July 2019 from Allinton (i) requesting CB and LBC to satisfy the default judgments within 21 days and (ii) stating that Allinton shall otherwise present a petition for a winding up order in respect of CB and LBC;
- (b) Notwithstanding the above:
  - (i) CB and LBC are currently negotiating with Allinton on a repayment plan and Allinton has agreed not to enforce the default judgments whilst negotiations are ongoing;
  - (ii) The Group has also engaged WongPartnership LLP ("**WP**") on 25 July 2019 (not 23 July 2019 as stated in the Announcement) to take steps to apply on behalf of CB and LBC to set aside the said default judgments.

Shareholders and potential investors of the Company are advised to read this announcement and any further announcements made by the Company carefully. Shareholders and potential investors of the Company should consult their stockbrokers, bank managers, solicitors or other professional advisers if they have any doubt about the actions they should take.
