The transfer of the Cache REIT Units was completed on 5 March 2020 and a total of 111,656,105 units in Cache Logistics Trust were transferred to LOGOS Units No. 1 Ltd..

As such, ARA Real Estate Investors V Limited has ceased to hold a direct interest in the Cache REIT Units, and ARA RE Investment Group Limited (which holds 100 per cent. of the shares of ARA Real Estate Investors V Limited) and ARA RE Investment Group (Singapore) Pte. Ltd. (which holds 100 per cent. of the shares of ARA RE Investment Group Limited) have ceased to hold a deemed interest in the Cache REIT Units.


