SIIC Environment Awarded a Wastewater Treatment Project in Shandong Province and Announced Commercial Operation of a Wastewater Treatment Plant Project in Yongxin, Jiangxi Province

This is a voluntary announcement made by SIIC Environment Holdings Ltd. ("SIIC Environment" or the "Company", together with its subsidiaries as the "Group"), a water treatment and environmental protection company listed on the Mainboard of the Singapore Exchange Securities Trading Limited and the Mainboard of The Stock Exchange of Hong Kong Limited.

The Company is pleased to announce that SIIC Environment Holdings (Weifang) Co., Ltd. (上實環境水務股份有限公司, "SIIC Weifang"), an indirectly 75%-owned subsidiary, has signed an agreement on concession rights on resumption and upgrade of the Weifang City Shawo Wastewater Treatment Plant Project ("Shawo project") with the Weifang City Administrative Bureau in the People's Republic of China (the "PRC"). The total design capacity of the Shawo project is 100,000 tonnes/day, which will be constructed in two phases. The design capacity of the first and second phase will be 60,000 tonnes/day and 40,000 tonnes/day, respectively. The discharge standard is set as Grade 1A with the water tariff priced at RMB1.705/m³.

The concession period spans ten years. Once the expiration of the current concession, SIIC Weifang shall have the priority to obtain the concession on operating the project under the same conditions.

In addition, the Company through its subsidiary, Ranhill (Yongxin) Water Co. Ltd (聯熹(永新)水務有限公司, "Ranhill (Yongxin)"), the first phase of Yongxin Industry Development Zone

Comprehensive Wastewater Plant Project ("Yongxin Project") has commenced commercial operation in Ji'an, Jiangxi Province in the PRC since 23 March 2019. The total design capacity of Yongxin Project is 10,000 tonnes/day with discharge standard as Grade 1B, and water tariff is priced at RMB1.91/m³.

These projects are expected to contribute to the Group's performance positively going forward.
