(i) David Todd Dollinger is a beneficiary of 5,838,384 Ordinary Shares of the Listed Issuer held in trust by the Meitav Dash Trust Ltd.; and

(ii) David Todd Dollinger has 45% shareholding interest in T.D.L International Directions Ltd. ("TDL") (formerly known as Trendlines International Ltd.).

TDL holds approximately 99.8% of the shareholding interest in Trendlines Venture Management Ltd., which is the general partner of Trendlines Venture Partners L.P., which, in turn, is the general partner of TIF, a fully-invested venture fund that held 3,251,418 Ordinary Shares of the Listed Issuer ("TIF Shares") prior to the Distribution.

In this context, David Todd Dollinger is indirectly interested in the TIF Shares because David Todd Dollinger is a director and shareholder of Trendlines Venture Management Ltd., (which, as noted above, is the general partner of Trendlines Venture Partners L.P., which, in turn, is the general partner of TIF), and Trendlines Venture Partners L.P. (as the general partner of TIF) has the exclusive right and power to manage the business and affairs of TIF, which includes the authority to dispose of, or to exercise control over the disposal of, the TIF Shares.

Following the distribution of TIF shares, TDL and Trendlines Venture Partners L.P. would hold 231,020 shares and 94,118 shares, respectively.

(a) David Todd Dollinger has not sold or otherwise disposed of any of the shares which he holds personally in the Listed Issuer. The change in the deemed interests of David Todd Dollinger is merely the result of the distribution in kind to TIF's limited partners (leading to a decrease in the deemed interest shareholding percentage).

(b) The percentage of issued share capital before and after the change is calculated based on the total number of issued share capital of the Listed Issuer of 508,741,749 shares as of the date of this transaction.

(c) Paragraph 8 of the Initial Announcement had wrongly indicated the deemed interest BEFORE the transaction as 9,089,802 shares, the correct number should be 9,414,940 shares. Consequently, the total number of shares held BEFORE the transaction should be 22,781,980 instead.

(d) Paragraph 8 of the Initial Announcement had wrongly indicated the deemed interest AFTER the transaction as

5,878,485 shares, the correct number should be 6,203,623 shares. Consequently, the total number of shares held AFTER the transaction should be 19,570,663 instead.
