**RAFFLES MEDICAL GROUP LTD SCRIP DIVIDEND SCHEME  
– ISSUE PRICE OF NEW SHARES**

The Board of Directors of Raffles Medical Group Ltd (the **Company**) had earlier announced on **26 June 2020** the following:

(a) The Application of the Scrip Dividend to the Final Dividend

The application of Raffles Medical Group Ltd Scrip Dividend Scheme (the **Scheme**) to the final dividend of 2.0 Singapore cents per ordinary share (**Share**) for the financial year ended 31 December 2019 (the **FY2019 Dividend**); and

(b) The Record Date

The record date for determining shareholders' entitlements to the FY2019 Dividend (**Record Date**).

Further to the above, the Directors of the Company wish to inform that for the purposes of the application of the Scrip Dividend Scheme (the **Scheme**) to the FY2019 Dividend, the issue price of the fully paid new ordinary shares of the Company (**New Shares**) to be issued to shareholders who have elected to participate in the Scheme, in lieu of part or all of the cash amount of the FY2019 Dividend, is S\$0.76 for each New Share, at not more than 10% discount of the arithmetic average of the daily volume weighted average price of a Share on the Singapore Exchange Securities Trading Limited (**SGX-ST**) for each of the Market Days during the period commencing on the day on which the shares were first quoted Ex-Distribution on the SGX-ST after the announcement of the FY2019 Dividend and ending on 4 August 2020 (being the Record Date for the FY2019 Dividend).

Shareholders not participating in the Scheme will receive the FY2019 Dividend in cash.

The FY2019 Dividend will be paid on or about 16 September 2020.

Notices of Election for the scrip elective with respect to the FY2019 Dividend will be despatched to eligible shareholders on or about 13 August 2020. A copy of the Scheme Statement, setting out the terms and conditions of the Scheme, is available upon request from the Company's Share Registrar, M&C Services Private Limited, 112 Robinson Road #05-01, Singapore 068902.
