- 2. There will be no option for Unitholders to participate virtually. A Unitholder (whether individual or corporate) who wishes to exercise his/her/its voting rights at the AGM may (a) vote at the AGM in person via the electronic poll voting system; or (b) appoint his/her/its proxy(ies), which may include the Chairman of the AGM ("Chairman"), to attend, speak and vote on his/her/its behalf at the AGM. A proxy need not be a Unitholder.
- 3. This Proxy Form is not valid for the use by investors holding units in Prime US REIT ("Units") through relevant intermediaries and investors holding through Supplementary Retirement Scheme ("SRS", and the investors, "SRS Investors") and shall be ineffective for all intents and purposes if used or purported to be used by them. A person who holds Units through relevant intermediaries (other than SRS Investors) who wishes to participate in the AGM should contact the relevant intermediary through which they hold such Units as soon as possible in order for the necessary arrangements to be made for their participation and voting at the AGM.
