Ng Chee Siong ("RN") has a deemed interest in an aggregate of 750,615,044 Stapled Securities as follows:

(a) Far East Organization Centre Pte. Ltd. has a direct interest in 196,396,847 Stapled Securities. The Estate of Ng Teng Fong (the "Estate") has a controlling interest in Far East Organization Centre Pte. Ltd.. RN is a beneficiary of the Estate and is therefore deemed to be interested in the 196,396,847 Stapled Securities in which Far East Organization Centre Pte. Ltd. has an interest.

(b) Golden Development Private Limited has a direct interest in 447,315,963 Stapled Securities. The Estate has a controlling interest in Golden Development Private Limited. RN is a beneficiary of the Estate and is therefore deemed to be interested in the 447,315,963 Stapled Securities in which Golden Development Private Limited has an interest.

(c) FEO Hospitality Asset Management Pte. Ltd. has a direct interest in 106,902,234 Stapled Securities. The Estate has a more than 20% interest in Far East Organization Pte. Ltd., which in turn has a controlling interest in Far East Orchard Limited, which in turn has a more than 20% interest in FEO Hospitality Asset Management Pte. Ltd.. The Estate also has a controlling interest in Far East Organization Centre Pte. Ltd., which in turn has a controlling interest in FEO Asset Management Pte Ltd, which in turn has a controlling interest in FEO Hospitality Asset Management Pte. Ltd.. RN is a beneficiary of the Estate and is therefore deemed to be interested in the 106,902,234 Stapled Securities in which FEO Hospitality Asset Management Pte. Ltd. has an interest.

Immediately before the transactions which are the subject of this Form 3, RN, as a beneficiary of the Estate, also had a deemed interest in 166,420,277 Stapled Securities held by Oxley Hill Properties Pte Ltd as the Estate has a controlling interest in Golden Development Private Limited which in turn has a controlling interest in Oxley Hill Properties Private Limited. Following the disposal of the 166,420,277 Stapled Securities by Oxley Hill Properties Pte Ltd via off-market transactions, RN ceased to have a deemed interest in the 166,420,277 Stapled Securities previously held by Oxley Hill Properties Pte Ltd.
