The Board of Directors (the “**Board**”) of ValueMax Group Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) is pleased to announce that both its 3-month Series 018 Issuance and 6-month Series 011 Issuance which were both launched on 17 March 2026 have closed today at 2:00 p.m. (Singapore time). Both issuances have received strong demand from investors, with the Company raising S\$31.12 million from the 3-month Series 018 Issuance and S\$15.26 million from the 6-month Series 011 Issuance. The digital securities to be issued by the Company to the subscribers of the 3-month Series 018 Issuance and the 6-month Series 011 Issuance will be listed on the ADDX digital platform on 1 April 2026.

Amongst the subscribers of the 3-month Series 018 Issuance, Mr Tan Soon Liang, Mr Yeah Chia Wei and Madam Tan Hong Yee had subscribed for S\$0.40 million, S\$1.22 million and S\$4.80 million respectively, amounting to 20.34% of the 3-month Series 018 Issuance. Mr Tan Soon Liang is an Independent Director of the company. Mr Yeah Chia Wei is a key executive of the Company, holding the designation of Chief Credit and Risk Officer, is son of Mr Yeah Hiang Nam, the Executive Chairman of the Company. Madam Tan is a controlling shareholder and wife of Mr Yeah Hiang Nam.

Amongst the subscribers of the 6-month Series 011 Issuance, Mr Tan Soon Liang and Ms Yeah Lee Ching had subscribed for S\$0.60 million and S\$0.30 million respectively, amounting to 5.86% of the 6-month Series 011 Issuance. Ms Yeah Lee Ching is an Executive Director of the Company and daughter of Mr Yeah Hiang Nam

The Company will make further announcements as and when there are other material developments in respect of the CP Facility, the 3-month Series 018 Issuance and/or the 6-month Series 011 Issuance.
