ANNOUNCEMENT ON AIR BAG TRIGGER SUSPENSION

Unless otherwise defined, the capital terms in this Announcement shall bear the same meaning in the relevant Supplemental Listing Document dated 22 June 2021 in relation to the DLCs.

SG Issuer (the “**Issuer**”) would like to notify the holders of the European Style Cash Settled Long Certificates relating to the Ordinary shares of Ping An Healthcare and Technology Company Limited (the “**Underlying Stock**”) with a Daily Leverage of 5x with counter code DCBW (the “**DLCs**”) issued by the Issuer and listed on the Singapore Exchange Securities Trading Limited (“the **SGX-ST**”) that the Underlying Stock price dropped by 15% at 1:33:57 PM (the “**Trigger Time**”) on 29 October 2021, and the Air Bag Mechanism was triggered at the Trigger Time in accordance with the terms and conditions of the DLCs. Trading and market making activities for the DLCs have been suspended and the value of the Underlying Stock price will be adjusted intra-day to the New Observed Price which shall be the minimum value of the Underlying Stock, during 15 minutes after the Trigger Time.

The Issuer will release a further announcement to inform the holders when trading and market making activities for the DLCs resume.
