The Offeror has on 9 April 2021 completed the exercise of its right of compulsory acquisition of Shares in the Company under Section 215(1) of the Companies Act of Singapore.

International Press Holdings Pte Ltd ("IPH") holds 524,082,564 shares in the Offeror, representing approximately 82.33% of the total issued shares of the Offeror. IPH is equally owned by by Ze Hua Holdings Pte. Ltd. ("Ze Hua") and Chee Chun Holdings Pte. Ltd. Mr Low Song Take is deemed interested in the shares in the capital of the Company by virtue of his shareholding in Ze Hua. Mr Low Song Take also holds 1 share in the Offeror in his own name and jointly holds with his spouse, Leong Shook Wah, 49,236,000 shares in the Offeror, representing approximately 7.74% of the total issued shares of the Offeror. Mr Low Song Take is deemed interested in the Shares held by the Offeror.
