RESPONSES TO QUERY FROM SINGAPORE EXCHANGE SECURITIES TRADING LIMITED ON TRADING ACTIVITY

<u>Question 3</u>: Can you confirm your compliance with the listing rules and, in particular, Catalist Rule 703?
