

ALLOTMENT AND ISSUANCE OF SHARES PURSUANT TO WARRANT EXERCISE

The Board of Directors (the "**Board**") of ValueMax Group Limited (the "**Company**") wishes to announce the number of issued ordinary shares of the Company has increased from 803,761,089 ordinary shares (inclusive of 100,000 treasury shares) to 807,994,957 ordinary shares by way of allotment and issuance of 4,233,868 new ordinary shares in the capital of the Company pursuant to the exercise of 4,233,868 warrants at the exercise price of \$\$0.36 each, on 8 April 2024.
