

Olam Group 2023 SGX Core ESG Metrics

About this Index

The SGX Core ESG Metrics, first published in December 2021, is a set of 27 core metrics published by the Singapore Exchange. The recommended list is intended to guide ESG reporting towards a standardised format for issuers and investors, and is mapped against globally-accepted sustainability reporting frameworks such as the Global Reporting Initiative (GRI). As a public listed company on the mainboard of the Singapore Exchange, Olam Group Limited (formerly known as Olam International Limited) has reported on sustainability metrics since before its launch of the SGX Core ESG Metrics, however this marks our first standalone content index for the SGX Core ESG Metrics, which aims to enhance the accessibility of the SGX disclosures for our stakeholders. This index references the latest version of the SGX Core ESG Metrics available at the time of publication (i.e. version April 2023).
