Wilmar International Limited (the "Company" or "Wilmar") wishes to announce the following:

Establishment of associated company

1. W&F Bio B.V. (Dutch Associated Company)

W&F Bio B.V. ("W&F") is a 50-50 joint venture between Wilmar Europe Holdings B.V. (a direct wholly-owned subsidiary of Wilmar) and Fox Petrolifera Italiana S.p.a. (which is not related to the Wilmar Group). W&F has a share capital of EUR18,000. The principal activity of W&F will be trading of biodiesel.

Change in shareholding in associated company

2. Global Oils Limitada (Mozambique Associated Company)

Wilmar Trading (Mauritius) Limited ("WTML"), an indirect 78.44% subsidiary of Wilmar, has acquired a 50% equity interest in Global Oils Limitada ("GOL") from Global Industries Limited ("GIL"), an indirect 37.5% associated company of Wilmar, for a total consideration of Mozambique Meticals 50,000. The purchase consideration was arrived at on a willing buyer, willing seller basis. Before this acquisition, Wilmar held an indirect 36.75% equity interest in GOL through GIL. Following the completion of the above acquisition, GOL is now an indirect 57.97% owned subsidiary of Wilmar. The principal activity of GOL is storage of agricultural commodities.

4. Wilmar Africa Commodities SA (Cote d'Ivoire Subsidiary)

Wilmar Africa Commodities SA ("WAC"), a dormant company which was a direct wholly-owned subsidiary of Wilmar Fertilizer Indonesia Pte Ltd, which is in turn, a direct wholly-owned subsidiary of Wilmar, was removed from the Register of Companies and ceased to be a subsidiary of Wilmar in February 2015.
