Pursuant to the Issuer's first omnibus announcement issued on 6 June 2024 (the "Omnibus Announcement 1") and the Placement Announcement issued on 6 June 2024 (the "Placement Announcement"), Hin Chin Qui had a deemed interest in 2,000,000,000 Placement Shares and 1,000,000,000 Warrant Shares (as defined in the Omnibus Announcement 1).
