City Strategic Equity Pte. Ltd. ("CSEPL") entered into a share sale and unit purchase agreement on 29 April 2019 with Tikehau Investment Management Asia Pacific Pte. Ltd. and Shanghai Summit Pte. Ltd. ("SUPA"), pursuant to which Shanghai Summit Pte. Ltd. agreed to procure the sale of 75,600,000 units in IREIT Global ("IREIT Units") held by Goodness Investments Limited (the "Summit IREIT Units") to CSEPL.

Additionally, CSEPL entered into a separate unit purchase agreement with Mr Lim Chap Huat ("UPA") on 29 April 2019 pursuant to which CSEPL acquired 3,000,000 IREIT Units from Mr Lim Chap Huat (the "LCH IREIT Units" and the Summit IREIT Units, the "Acquired IREIT Units").

Accordingly, CSEPL has a deemed interest in the Acquired IREIT Units, which represent approximately 12.4% of the total issued units in IREIT Global.

Davos is deemed to be interested in the IREIT Units held by CSEPL in IREIT Global by virtue of the provisions of Section 4 of the Securities and Futures Act, Chapter 289.
