**1. Issuance of the first sub-tranche of Tranche 1 Notes**

The Board of Directors (the "**Board**") of Magnus Energy Group Ltd. ("the **Company**") wishes to announce that the first sub-tranche of the Tranche 1 Notes have been duly issued to the Subscriber on 6 November 2014 for the amount of S\$500,000 in accordance with the terms and conditions of the Notes Issue.

The Company will make further announcements on the utilisation of the net proceeds from the Notes Issue as and when the proceeds are materially disbursed.

**2. Allotment and issue of Shares pursuant to the conversion of the first sub-tranche of Tranche 1 Notes**

The Board wishes to announce that the Subscriber has, on 7 November 2014, exercised its rights to convert nine (9) Notes (Certificate Nos. 001 – 009) in respect of the first sub-tranche of the Tranche 1 Notes. The converted Notes, with an aggregate principal value of S\$450,000 will be converted into 62,500,000 Conversion Shares at the Floating Conversion Price of S\$0.0072 for each Conversion Share.

The Floating Conversion Price of S\$0.0072 was determined by taking 90% of the average of the traded volume weighted average prices per share for any three (3) consecutive Trading Days as selected by the Subscriber during the 30 Trading Days immediately preceding the relevant Conversion Notice dated, 7 November 2014..
