While Form C will be attached to the announcement template, it will not be disseminated to the public and is made available only to the Monetary Authority of Singapore (the "Authority").

There must be no netting-off of two or more notifiable transactions even if they occur within the same day.

(a) up to 773,160 shares are comprised in the conditional Performance Share Plan 2010 ("PSP") Award of performance shares, subject to performance targets set over a three-year period, pursuant to the PSP. A minimum threshold performance is required for any performance share to be released. At the time of the award, the base number representing 100% of the award is 454,800 shares. The actual number of performance shares to be released is capped at 170% of the conditional PSP Award;

(b) 32,338 Shares are unvested restricted shares to be released according to the stipulated vesting periods pursuant to the RSP; and

(c) up to 109,200 shares are comprised in a conditional RSP Award of restricted shares, subject to performance targets set over a one-year period, pursuant to the RSP. A minimum threshold performance is required for any restricted share to be released. At the time of the award, the base number representing 100% of the award is 72,800 shares. A specified number of restricted shares to be released will depend on the extent of achievement of all performance conditions and will be delivered in phases according to the stipulated vesting periods.
