The arrangement was previously reduced by 15,000,000 shares to 84,480,000 shares.

This arrangement has been further reduced by 4,000,000 shares to 80,480,000 shares.

Michelle Cheo Hui Ning is deemed interested in the shares in SGHT in which she is one of the beneficiaries.
