NOTIFICATION OF MAJOR HOLDINGS IN SHARES REPRESENTING 7.39% VOTING RIGHTS IN STAFFLINE GROUP PLC ("Staffline")

The Board of Directors of HRnetGroup Limited (the "Company" and together with its subsidiaries, the "Group") wishes to announce that pursuant to DTR 5.1 of the Disclosure Guidance and Transparency Rules under the Financial Conduct Authority in United Kingdom, the Group has filed its notification of major holdings in accordance with TR-1: Standard Form for Notification of Major Holdings") as attached hereto as Appendix 1 to 3.

Under the Disclosure Guidance and Transparency Rules, a Notification of Major Holdings is required if the percentage of a person's voting rights in respect of his direct or indirect holding of shares or financial instruments exceeds 3% as a result of acquisition or disposal of shares or financial instruments in an issuer whose shares or financial instruments are trading on a regulated market in the United Kingdom.

Based on the notifications made, the Group was interested in 7.39% of the voting rights of Staffline. The Group acquired this shareholding interest in Staffline as an investment in furtherance of its strategy to opportunistically enter new markets in the human resources space.

The foregoing does not give rise to any material financial impact on the Group.
