## **ANNOUNCEMENT**

## ISSUE PRICE OF NEW UNITS PURSUANT TO THE DISTRIBUTION REINVESTMENT PLAN FOR THE 1Q FY14/15 DISTRIBUTION

4 August 2014 - Further to the announcement dated 24 July 2014 by Mapletree Commercial Trust Management Ltd., as manager of Mapletree Commercial Trust ("MCT" and as manager of MCT, the "Manager") in relation to the application of a Distribution Reinvestment Plan ("DRP") to the distribution of 1.95 Singapore cents per unit in MCT ("Unit") for the First Quarter Financial Year 2014/2015 from 1 April 2014 to 30 June 2014 ("1Q FY14/15 Distribution"), the Manager wishes to announce that the issue price of the new Units under the DRP is S\$1.3682 per Unit.

The issue price represents approximately 1% discount<sup>1</sup> to the adjusted volume-weighted average traded price<sup>2</sup> per Unit ("adjusted VWAP") for all trades on Singapore Exchange Securities Trading Limited (the "SGX-ST") for each of the Market Days<sup>3</sup> during the period of 10 Market Days prior to and ending on the books closure date ("BCD") on 4 August 2014.

The Notice of Election is expected to be dispatched to all Eligible Unitholders<sup>4</sup> on or around 8 August 2014. The Manager will announce further details about the dispatch of DRP documents in due course.

The issue price represents approximately a 1.8% discount to the unadjusted volume-weighted average traded price per Unit for all trades on the SGX-ST during the period of 10 Market Days prior to and ending on the BCD.

The adjusted VWAP is computed based on the volume weighted average traded price per Unit of all trades on the SGX-ST for each of the Market Days during the period of 10 Market Days prior to and ending on the BCD and subtracting the 1Q FY2014/15 Distribution for each of the Market Days prior to the first day of "ex-distribution" trading.

"Market Day" means a day on which the SGX-ST is open for trading in securities.
