**THE COMPANY'S REQUEST FOR INFORMATION PURSUANT TO  
SECTION 137F OF THE SECURITIES AND FUTURES ACT (CAP. 289) ("SFA")**

---

The board of directors (the "**Board**") of Imperium Crown Limited (the "**Company**") refers to the Company's announcements dated 10 May 2016, 3 June 2016 and 8 June 2016 (enclosing a Notice of Extraordinary General Meeting ("**EGM**") dated 7 June 2016 given by the Relevant Parties).

The Board wishes to announce that on 16 June 2016, the Company had given notice in writing to Ms Tan Geok Bee ("**Ms Tan**") (one of the Relevant Parties who gave Notice of EGM on 7 June 2016), and Third Rose Asia Sdn Bhd ("**TRA**") to require them to provide the requisite information as per Section 137F of the SFA, by 12 noon on 20 June 2016.

On 21 June 2016, Ms Tan responded to the Company stating that:

*"Your presumption at paragraph 3 of your letter is incorrect. I am the beneficial owner of TRA and therefore the Shares*

*In answer to paragraph 4 of your letter, TRA purchased the Shares from Lim Chuan Lam. As TRA does not have a CDP account, I hold TRA's legal interest in the Shares on its behalf. No other person is entitled to control the voting rights attached to the Shares.*

*In answer to paragraph 9 of your letter, TRA is the owner of the Shares. However, as it does not have a CDP account to hold the Shares, I hold TRA's legal interest in the Shares on its behalf and TRA therefore has a deemed interest in the Shares.*

*Accordingly, TRA is the legal owner of the Shares and I am the beneficial owner of the Shares."*

Copies of the Company's letter dated 16 June 2016 and Ms Tan's reply dated 21 June 2016 are enclosed to this announcement.

The Company has not received any response from TRA.

The Board is taking the necessary advice in relation to the above, and will update the Company's shareholders at the appropriate stage, of further developments, if any.

In the meantime, the Company's shareholders and investors are advised to exercise caution when dealing in the shares of the Company.
