The Board of Directors (the "**Board**" or "**Directors**") of Singapore Kitchen Equipment Limited (the "**Company**" or "**SKE**", together with its subsidiaries, collectively, the "**Group**") refers to the Previous Announcements in respect of the Extension Applications and wishes to provide updates on the Company's operations and progress in meeting key milestones pursuant to the Waiver Conditions.

1. Update on Company's operations

Save as disclosed in the Previous Announcements, there are no material updates to the Company's operations. Future updates will be made when there are any developments.

2. Update on court proceedings

The Board refers to the Company's previous announcements, including announcements dated 11 April 2022, 13 April 2022, 25 April 2022, 8 June 2022, 4 July 2022, 14 June 2023, 15 June 2023, 25 April 2026, 4 June 2026 and 1 July 2026, in relation to the investigations by the Commercial Affairs Department ("**CAD**").

The Board wishes to update that the legal counsels attended a Pre-Trial Conference ("**PTC**") on 26 August 2026 in relation to the proceedings involving Ms Chua Chwee Choo ("**Ms Chua**") and Ms Koh Sai Eng ("**Ms Koh**").

Key court directions and next steps arising from the PTC include:

- The Judge ordered that the respective Criminal Case Management System ("**CCMS**") sessions for Ms Chua and Ms Koh be scheduled before 25 September 2026.
- A subsequent PTC has been scheduled for 30 September 2026, at which the attendance of Ms Chua and Ms Koh is not required.
- Pending the above scheduled dates, no further action is required to be taken by Ms Chua and Ms Koh.

The Company will continue to monitor the progress and make immediate announcements when there are further developments.

Shareholders and potential investors of the Company are advised to read this announcement and any further announcements by the Company carefully. Shareholders are advised to refrain from taking any action in respect of their securities in the Company, which may be prejudicial to their interests, and to exercise caution when dealing in the securities of the Company.
