On 2 November 2015, Croesus Retail Trust ("CRT") issued 1,193,500 new Units to Croesus Merchants International Pte. Ltd. ("CMIPL") and (ii) 492,580 new Units to Croesus Retail Asset Management Pte. Ltd. ("CRAM") pursuant to the Rights Issue.

(i) CMIPL has a direct interest in an aggregate of 6,618,500 units in CRT (the "Units") and (ii) CRAM has a direct interest in an aggregate of 531,580 Units. CMIPL is the ultimate holding company of CRAM and is therefore deemed to be interested in the Units held by CRAM.

Mr Yong Chao Hsien Jeremy has a 49% beneficial ownership in CMIPL and is therefore deemed to have an interest in the Units held by CMIPL directly and held by CMIPL through CRAM.
