Aberdeen Global was incorporated in Luxembourg on 25 February 1988 as a société anonyme under the laws of the Grand Duchy of Luxembourg and qualifies as an open-ended société d'investissement à capital variable (a "SICAV") with collective investment in transferable securities ("UCITS") status. Aberdeen Global has appointed Aberdeen International Fund Managers Limited as Investment Manager, and Aberdeen Asset Managers Limited, Aberdeen Asset Management Inc. and Aberdeen Asset Management Asia Limited as Investment Advisers.

The Investment Manager and Investment Advisers have been making relevant notifications in the security.

However, it was noted recently that Aberdeen Global as the owner of the security is also required to make the notification separately under the Singapore regulations. This is a retrospective notification of Aberdeen Global's interest in the security.
